

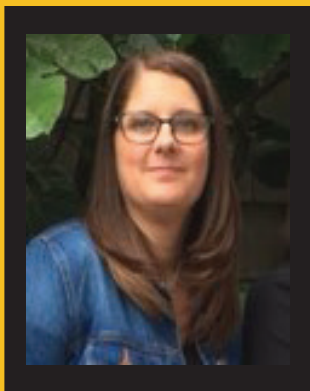

1st Annual Early Learning Hub Conference

The Data and Evaluation Work Group will be hosting the first Annual Early Learning Hub Conference at Linn-Benton Community College on Friday, October 20, from 9:30-3:30pm. Based on the Collective Impact Model, this conference strives to create a common understanding of self-regulation, the importance of children's self-regulation skills on their success in kindergarten, and to highlight activities that support the development of self-regulation happening in our region.

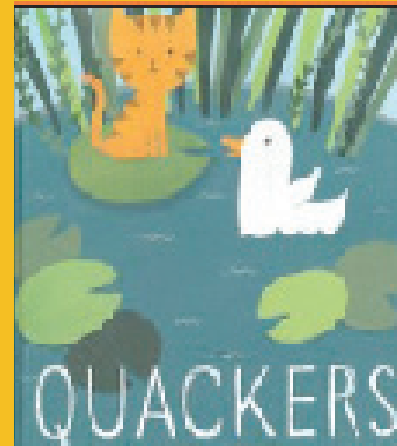

JumpStart Gears up for Another Year

This year the JumpStart "Read for the Record" will be held on Thursday, October 19, 2017, and the new books have just arrived in our office!

To date 24 local agencies have signed up to read on October 19th, with about 900 children participating. We will supply each child with a certificate of participation for attempting to break the world record, and one book will be provided for each classroom, in English and/or Spanish.



Pollywog Updates

The Pollywog Project continues to rumble along and gain momentum. We currently have nearly 150 families in the database, and have been able to supply them with prenatal and parenting classes, resources and information, and referrals to other partner agencies.

Unfortunately, at the end of August we lost our Project Specialist, Cathy Corkery. Prior to coming to us, Cathy was a Health and PE teacher at Linus Pauling in Corvallis, and when she got word that her old job was available again, she couldn't resist the pull to return to education. We will miss her input and appreciate so much all of the work that she did to further this project.

This month meetings have begun with Lincoln County partners, introducing them to the functionality of the project, and individual trainings are being held with local Linn County partners. We are working our way through the partner list, so you will be getting an email soon!

Hub Work Group Updates:



WORK GROUP DAY: The next Hub Work Group Day is scheduled for Thursday, November 9, 2017, at the Newport Public Library. Please plan on attending.



DATA & EVALUATION WORK GROUP: The Data & Evaluation Work Group did not meet in August because of a timing conflict with the Early Learning Hub Collaborative meetings, scheduled by the State.



HEALTH CARE INTEGRATION WORK GROUP: The Health Care Integration Work Group met on Wednesday, August 23, 2017, at the Benton County Sunset Building in Corvallis. The group discussed the ASQ Training and Tracking Initiative, plans for future START trainings, and an update on the RHIC project. At the next meeting, they will be discussing ACEs training and the 2018 CCO Incentive Metrics.



EARLY CHILDHOOD COORDINATING COUNCIL: The Early Childhood Coordinating Council did not meet in August because of a timing conflict with the Early Learning Hub Collaborative meetings, scheduled by the State; however, two subcommittees of the ECCC did meet, one to discuss pre-school intake, and one to discuss early childhood workforce development.



PARENT ENGAGEMENT COMMITTEE: The Parenting Engagement Committee met on Tuesday, August 29, 2017, at the Oregon Coast Community College in Newport. The group discussed upcoming parent engagement events that have been targeted by the group, "Attendance" Focus groups with parents (discussing absenteeism), and a proposed reporting system.
