LBCC Part of Healthy Communities Grant Initiative

The Northwest Health Foundation has awarded \$750,000 in grant funds to 25 communities in Oregon and Southwest Washington as part of its Healthy Beginnings+Healthy Communities Initiative.

Launched in 2014, the initiative will support community-led efforts to improve health from birth to high school by 2020.

The Linn Benton Lincoln Early Learning Hub, coordinated by Linn-Benton Community College, will receive \$30,000 from the initiative to help create an accessible and collaborative system of support and care for families and children in Linn, Benton and Lincoln counties.

"Birth, kindergarten readiness, and high school readiness are critical stages in building lifelong health and family prosperity," said NWHF President and CEO Nichole June Maher. "Through the Healthy Beginnings+Healthy Communities Initiative, NWHF will help communities improve health during these crucial years."

Through their partner organizations, the Linn Benton Lincoln Early Learning Hub is working to develop capacity and infrastructure to help local parents and families most impacted by educational and health inequities in our communities.

Early Learning Hub partners include: Casa Latinos Unidos de Benton County and Organización Latinas Unidas; Corvallis MultiCultural Literacy Center; Old Mill Center; Iglesia Emanuel; St. Mary's Catholic Church and Strengthening Rural Families; (Linn County) Greater Albany Public School District's Welcome Center/Centro de Bienvenida; Oregon State University-Extension's Poder Comunitaria/Familias Activas Program; Harrisburg Actively Reaching Together Family Resource Center; St. Mary's Catholic Church and the Family Tree Relief Nursery; and (Lincoln County) Centro de Ayuda; Coastal Families Together; Yachats Youth and Family Activities Program; and Confederated Tribes of the Siletz Indians.

The grant also will support activities for communities to apply for a multi-year partnership in late 2015.
