On the Hub website, under "Our Region", we have a place that we can start putting this information out there.

If we intend to pursue the Open House idea, we should decide on the outcomes in advance. Do we want to only discuss data? Do we want to show what services are available in the area? Do we want to hold an Open House in each county? Take the concept to the other work groups to see if they want to participate?

There are other data groups (at OSU and PSU) that are also crunching early learning numbers, differently than we are. We viewed the Oregon School Readiness Research Consortium presentation on YouTube. If we have an Open House, these people are local and may be available to come and share this data.

DISCUSSION ITEM

3rd Grade Reading Assessments

We requested this information from the ESD, and had to get special permission to receive and view it. The ESD doesn't want this data to be released to the general public because some schools are so small that the teacher and class can be identified.

We're going to map the data with the other demographic data (free- and reduced-lunches, English language learners, etc.). EL Hub data is public. But the 3rd Grade scores provided by the ESD will not be released, just our synopsis of the data.

How do we want to think about drilling down on this data according to what the Governing Board has requested?

Current scores are released in late summer, so we are hoping to have the data in the fall.

One of the focuses could be what we can do to help kids get ready for school, and improve these scores. If we had activity sheets, or some other free materials that could be passed out to families to help them to get access to materials that will help their children.

DISCUSSION ITEM

Better Know Your Data

Anna has created a Tableaux presentation using Hub data. People can take the "quiz" and then continue clicking into our website for more information.

Can PowToon be used for "hard discussions"? It's light-hearted, but the data isn't.

Can we create a Meeting Notification MailChimp that has a data fact in it? A separate MailChimp just for data facts each week, or so?

Start with the Kindergarten Assessment Data? Childcare provider info? Food insecurity data? Medical Provider information?

What data will make a difference to our Hub partners?

Could we have hard copies of the data question prepared to hand-out at other work group meetings?

Create a Facebook post that invites readers to sign-up for a PowToon data fact.

Have Anna come up with the clear data points, and LeAnne could create the PowToon presentation.
