DISCUSSION ITEM	Old Business
Bettina Schempf has stepped down as co-chair of this committee, and we appreciate her efforts.	
MaiKia Moua is the new co-chair of this committee, and we want to welcome her.	

DISCUSSION ITEM	Pollywog Introduction (Cathy Corkery and LeAnne Trask)
Cathy discussed what the Pollywog Project is and how it is intended to work. She talked about meeting with partners and inviting groups to participate.	
LeAnne gave a brief demonstration of the Pollywog website and explained how all the pieces work together.	
There was discussion about how the referral portion of the program will work, and what families can expect when the Pollywog staff contact them. Several people discussed concern about Pollywog “overstepping” and getting involved in referrals and that Pollywog staff “didn’t know what they were doing.” It was stated that “Pollywog was not invited to participate in Lincoln county, and it will ruin their long-standing services.”	
Cathy spoke about what the mission of Pollywog is to “do no harm”, and that we will continue to meet with partner organizations to get their feedback and expertise.	
Cathy also spoke about an upcoming Pollywog Informational Meeting on March 7, from 10-12:00pm at Samaritan Albany General Hospital. All of our partners are invited to attend to voice their opinions and concerns.	

DISCUSSION ITEM	Oregon Rural Practice-based Research Network Findings (ORPRN)
In March 2016, we held a START training with pediatricians and their staff in Lincoln County. The Oregon Pediatric Society (OPS) led the training and introduced those attending to the Ages & Stages Questionnaire (ASQ). Approximately 20 pediatricians and their clinical staff attended.	
After the OPS training, a panel of community experts (from early intervention, early education, health department) spoke about how the ASQ is being used and what happens after they refer a child.	
After the START training, ORPRN conducted six months of technical assistance with five of the pediatricians and their staffs, helping them to implement what they learned into their practice. ORPRN presented the results of their training to the Data & Evaluation Work Group on 2/21/2017. One of the slides, entitled “Lessons Learned” from their presentation is available on Basecamp and the website.	
The entire presentation is a valuable resource and will be very helpful in planning future trainings.	

DISCUSSION ITEM	Future ASQ Trainings (Lynn Hall)
Julie Manning is helping with the planning process for future trainings. The first trainings will be held at the end of June.
