DISCUSSION ITEM	New Social Determinants of Health Recommendations
<p>LeAnne Trask presented information from IHN-CCO regarding Social Determinants of Health recommendations for 2020. These are housing, food security, and transportation. These recommendations align with current CCO metrics and will be referred to the Delivery System Transformation (DST) committee for grant applications.</p>	

DISCUSSION ITEM	Update from the Oregon Health Authority (OHA)
<p>LeAnne Trask presented IHN/CCO update information from OHA regarding COVID-19 infections in the state, dated 4/24/2020. Included in the information was the designation of the peak day of infections in Oregon as 4/10/2020, and projections for reopening the state. LeAnne also shared the most recent Daily Report from OHA, 5/11/2020.</p>	

DISCUSSION ITEM	Oregon Pediatric Society
<p>LeAnne Trask shared information from the Oregon Pediatric Society related to pediatric visits, including well-child and illness-related visits. The previous months had seen a 'significant decrease' in pediatric visits and related vaccinations and relayed concern about children falling behind on necessary vaccinations.</p> <p>Work group members discussed how even a two-month delay in vaccinations will mean younger children will be off the schedule that is needed for vaccination efficacy and childcare or school entrance.</p> <p>Lynn Hall shared data from the Data and Evaluations Work Group from 2019 that showed positive gains in vaccination rates in Linn and Lincoln counties (unchanged in Benton) and in Oregon as a whole.</p>	

DISCUSSION ITEM	Oregon Preschool Development Grant
<p>LeAnne Trask presented information from the Statewide Household Survey Results of the Strengths and Needs Assessment, Birth through Age 5. This was a report to the Oregon Early Learning Division and the Early Learning Council. The report is intended to inform planning for expansion and improvement of the state's early learning system.</p>	

Of particular interest is the online database of information called the Early Learning Map of Oregon (ELMO), which allows for more in-depth analysis of the data.

Work group members discussed some aspects of the data and its collection, including the area designated 'Frontier' in Oregon, expulsion rates, negative behavior in a classroom and how it is handled, and therapeutic classrooms.
