Preschool Promise

After delays due to the emergency situation with COVID-19, the Early Learning Division (ELD) has announced the Preschool Promise Grant Awardees. These funds mean the addition of 158 funded preschool slots in our region.

We are excited for our preschool partners and for the new families and children that will be served by this increase in available quality early childhood education in the Linn-Benton-Lincoln region.

According to the [ELD website](#), these awards are only part of the budgeted funds to the Early Learning Account investments, due to the impact of COVID-19 on Oregon's economy and budget. Updates will be shared as we receive them.

Weekly Child Care Partners Meetings

Alongside staff from Child Care Resource & Referral, Hub staff have been coordinating and participating in weekly outreach meetings to the Hub's child care partners.

These online meetings have been an open opportunity for partners around a variety of topics, including Emergency Child Care information, Preschool Promise applications and grants, and Coordinated Enrollment. They provide a connection not only for partners with Hub staff but also between partners.

Coordinated Enrollment

With the announcement of Preschool Promise Grant awards, the Hub will be moving forward with plans for Coordinated Enrollment, beginning with filling the new Preschool Promise slots.

More information is anticipated in the coming weeks from the state. All EL Hubs will work closely with the ELD as the coordinated enrollment process is designed. Because of the delay in the implementation of Coordinated Enrollment due to COVID-19, the timeline has been shortened. Regardless, the Hub and its staff are ready to jump into state-provided training as soon as its received.

Following training, outreach and recruitment will commence, to both existing and new families.

Family Connects

Work on Family Connects is continuing at a steady pace. Hub staff are meeting regularly online with Family Connects staff at Duke University.

One focus of Family Connects is on community alignment and a community alignment specialist in each county. Our Hub is fortunate to have already done much of this work in the Pollywog program and database. The Pollywog database meets Family Connects criteria as a resource and referral system. We are proud to report that the Pollywog database was referenced as a good example by Family Connects on a national call!

Currently, we are awaiting further directions from OHA regarding staffing and funding for an alignment position within the Pollywog team.
