Kristi asked the workgroup to consider how we operationalize each of the strategies.

Feedback included:

Involve the Parent Leadership Council to engage with families about what they

- need in the kindergarten transition process.
- How can we educate ourselves more about home visiting in our area and find ways to get strategically involved? We hope to leverage existing meetings, including the LBL Early Childhood Collaboration meetings, to meet this need.
 OPEC and PSU may also have resources and opportunities for coordination.
- Infant Mental Health Update. The central entity has been chosen, and they are working on building the warmline process. THE IMHA will be meeting again soon
- Getting substitutes so Kindergarten teachers could attend professional development
- Work with regional Superintendents to incorporate a dedicated day for a kindergarten teacher conference into upcoming school calendars. Could the statewide in-service day be used for this purpose?
- Funding and workforce sustainability and alignment across the region.

Kristi reviewed the Strategic Plan timeline. She thanked the workgroup for their efforts to create this plan.
